- The Restricted Stock Units vest in four annual installments beginning July 1, 2024, and will be settled by delivery of unrestricted shares of common stock on the vesting date.
- The Restricted Stock Units vest in four annual installments beginning July 1, 2025, and will be settled by delivery of unrestricted shares of common stock on the vesting date.
- The Restricted Stock Units vest in one installment on July 1, 2029, and will be settled by delivery of unrestricted shares of common stock on the vesting date.
